PUBLIC COMMENT

Larry Bean, City of Lompoc Public Works Director, addressed the board on the need for an FTIP amendment in order to get projects ready to send to Caltrans.

Scott McGolpin, County of Santa Barbara Public Works Director, spoke in support of the TTAC recommendation and also would like to have only Attachment A of the resolution approved. He also addressed the board on the funding needed to meet the County of Santa Barbara's needs. During the comment period he addressed the STIP funding issue presented by staff during their presentation.

Christine Andersen, City of Santa Barbara, spoke in support of the TTAC recommendation.

David Whitehead, City of Santa Maria, asked board to have staff submit an application for National Surface Transportation Discretionary grant program for the Santa Maria bridge project. Mr. Whitehead also asked board for approval of the TE funding for the Santa Maria Railroad Bikeway project.

Steve Lebard, Old Town Orcutt Revitalization, requested that SBCAG appropriate funding for the next phase of the Old Town revitalization.

Steve Wagner, City of Goleta, addressed the board on allocating money to local infrastructure. Would like the board to go with Certification A and authorize Executive Director to generate the FTIP amendment.

Motion to approve the programming of all \$20.025 million dollars of roadway stimulus funding for local agency projects through the population formula, with the exception of the \$1.5 million currently programmed for the Milpas /Hot Springs project and \$568,000 in TE programmed for the SM Railroad Bikeway project.

Proposition 1B projects currently under construction, including the Highway 101 Milpas to Hot Springs Project.

- Implementation of SB 375 and lack of state funding. SB 406 was passed out of the Senate Local Government committee and authorized any metropolitan planning organization responsible for implementing SB 375 to impose an additional vehicle registration fee on all cars registered within the county of up to \$2.00 to provide funding for the implementation of SB 375.
- Highway 101 CMIA Project – Widening of 101 between Mussel Shoals, Ventura County and Carpinteria creek in Santa Barbara County. Project is being considered by the state for a design-build contract which may accelerate project delivery.
- CALCOG Regional Issues Forum on April 30-May 1 in Monterey will be attended by Chair Alvarez and SBCAG members Hicks (CALCOG delegate) and Wolf (alternate CALCOG delegate).

13. CALTRANS DISTRICT DIRECTOR'S REPORT

Aileen Loe, Caltrans addressed the board on the following four items:

- Purisima Road Safety Improvement information meeting being held on Wednesday, April 22, 2009 from 5:30-7:30 p.m. in Lompoc.
- Highway 192 project has started and will be concluded in August.

Supervisor Carbajal asked that Caltrans address the graffiti issues that are taking place along the Milpas/Hot Springs retaining walls.
