Dale Stockdale addressed the board the on the Union Valley Parkway project between Highway 135 and Blosser Rd requesting that the board reconsider the funding approved for this project .

## 8. MEASURE A STRATEGIC PLAN

- A. Receive a presentation on the cash flow scenarios being developed for the Measure A Strategic Plan.

#### PUBLIC COMMENT

Steve Wagner, City of Goleta, addressed the board on TTAC and the challenges it faces in putting together funding scenarios. TTAC does not want to include RSTP funds in the strategic plan except for the amount of money necessary to pay for Highway 101 should other federal funding fall short.

Lanny Ebenstein, SB County Taxpayers Association, addressed the board on keeping the widening of Highway 101 a top priority.

Robin Hayhurst, Measure A Citizens Oversight Committee, addressed the board on the importance of the widening of Highway 101 and possibly keeping the annual allocations off the top flexible.

Toru Miyoshi addressed the board asking for justification of allocating local taxes to fix state highways.

Andy Caldwell, COLAB, addressed the board emphasizing that the widening of Highway 101 is the highest priority and the remaining money will be split between the North and South County.

Hamid Bahadori addressed the board asking them to keep the promise of widening Highway 101 a top priority.

Laurie Tamura addressed the board stating the widening of Highway 101 is a South county project. North County projects are important to the Orcutt and Santa Maria valley areas and to please keep them a priority.

Tim Mahoney, Chairman, Santa Barbara Technology and Industry Association, addressed the board on Highway 101 project. Believes it is a necessary project that will benefit both South and North Counties.

Motion made to receive presentation and bring back the Parsons Brinckerhoff contract amendment to the January 2010 board meeting to determine how much funding is left on the contract and how much more money will be required to complete Strategic Plan.

## 12. EXECUTIVE DIRECTOR'S REPORT

Jim Kemp, Executive Director, reported on the following:

- The North County and South Coast Subregional Meetings will take place on December 2, 2009 and not December 9th as originally anticipated.
- Michael Cheng, Measure A Citizens Oversight Committee has resigned due to work schedule conflicts. The South Coast Subregional Committee will need to nominate a replacement.
- Decisions made on the Sustainable Transportation Advocates vs. SBCAG lawsuits.
- Bids opened for the Hollister/Cathedral Oaks interchange project in Goleta.

#### 13. CALTRANS DISTRICT DIRECTOR'S REPORT

Rich Krumholz, Caltrans, reported on the following:

- The state sold 4.1 billion dollars in bonds. 307 million went to transportation.
- Bond funding to continue construction on the Milpas/Hot Springs project is now secure through 2010.
- Milpas/Hot Springs project is almost 50% complete. The roundabout in Montecito is complete.
- Ribbon cutting of Los Carneros interchange landscaping project.
- Hollister/Ellwood project moving ahead.

Mayor Blum asked Caltrans to check on the lighting and signage at the Hot Springs roundabout.

Supervisor Centeno suggested that the CHP be involved in the discussion of the Union Valley Parkway design.

## **PUBLIC COMMENT**

Marc McGinnes addressed the board on the Caltrans lawsuit, the Cold Springs Bridge Project and the diversion of funds.

He urged the board not to support the barriers project and instead support alternative suicide prevention measures.
